Fleeces must be in a cloth or heavy duty plastic bag and clearly identified with a cardboard slip pinned to the inside of the fleece bag stating, Name, Address and Telephone Number of the exhibitor and the name of the Alpaca and any instructions and postage for return of fleece.
Subject to the number of entries any class maybe be split, combined or cancelled.
All fleeces being shown must be the bona fide property of the exhibitor.
Fleeces to be from within the last 12 months shearing
Fleeces are to be left in the Pavilion for display for the duration of the show and collected at 4pm on Sunday.
